# MINUTES CONCORD TOWNSHIP BOARD OF TRUSTEES REGULAR SESSION JANUARY 8, 2020

The Concord Township Board of Trustees met in Regular Session at 10:00 a.m. on Wednesday, January 8, 2020. Fiscal Officer Pat Quillen called the meeting to order and led the Pledge of Allegiance. Trustees Neil Rhoades, Don Pence, and Tom Mercer were present. Road Superintendent Brandt Miller and Fiscal Officer Pat Quillen were also present.

**Nominations for Chairman:** Pat Quillen called for nominations for the 2020 Chairman. Don Pence nominated Tom Mercer and was supported by Neil Rhoades. There were no other nominations and the roll was called: Don Pence – Aye; Tom Mercer – Aye; Neil Rhoades – Aye. With that, Tom Mercer took charge of the meeting.

**Nominations for Vice Chairman:** Tom Mercer nominated Don Pence for 2020 Vice-Chairman. Neil Rhoades seconded the nomination. There were no other names offered and no discussion. The roll was called: Tom Mercer- Aye; Neil Rhoades – Aye; Don Pence – Aye.

**Chairman's Comments:** Tom Mercer welcomed Neil Rhoades to the Board of Trustees and noted his 46 years of service to the Township. He introduced Bill Whidden who served as a Trustee for 14 years and will begin as the Township's Fiscal Officer on April 1, 2020. Tom Mercer also welcomed Brandt Miller who became the Road Superintendent on January 1. He started work at Concord Township in March of 2007, so he has nearly 13 years of service.

<u>Minutes</u>: Don Pence made a motion to approve the Minutes of December 31, 2019 and was seconded by Tom Mercer. Tom Mercer and Don Pence signed the Minutes indicating acceptance.

- 1. Sgt. Randy Slusher from the Miami County Sheriff's Office stated that he had no serious issues to report. Tom Mercer reported receipt of a call from a resident who complained of littering on Swailes Road. Tom Mercer thanked the Sheriff's Office for everything they do for the Township.
- 2. Tom Mercer thanked Miami County Prosecutor Tony Kendell and his Chief Civil Assistant Chris Englert for coming out this morning and noted that the Trustees will meet with counsel in an executive session at the end of this meeting.

- C.–F. Tom Mercer asked that the next four items be grouped together and Don Pence made the following motion to:
  - Approve the IRS mileage reimbursement at the rate published by the IRS at the time the expense is incurred
  - Approve the reimbursement of expenses for elected officials and authorized employees to attend seminars and conferences
  - Approve continuation of the Ohio Township Association Group Life, Dental, and Vision insurance for all elected officials and full-time employees
  - Approve the Inventory Report for the Miami County Engineer's Office

Neil Rhoades seconded that motion and the vote was recorded: Don Pence – Aye; Tom Mercer – Aye; Neil Rhoades – Aye.

- H. Approve Charges and Warrants: Don Pence made a motion to approve and pay Charges 1- through 4-2020 and Warrants 24986 and 24987 (24985 was voided). Tom Mercer seconded the motion and the Warrants were signed.
- I. Seasonal Employee: Neil Rhoades moved to have Jeff Sweigart return as snowplow driver as needed this year at the rate of \$15.00 per hour. Don Pence seconded the motion and all three Trustees voted in favor.

**Executive Session:** At 10:19 a.m., Tom Mercer made a motion to enter Executive Session pursuant to Ohio Revised Code section 121.22 (G)(2) to consider the disposition of unneeded, obsolete, or unfit-for-use property in accordance with Ohio Revised Code section 505.10 as premature disclosure of information would give an unfair competitive or bargaining advantage to a person whose personal, private interest is adverse to the general public interest. Don Pence seconded the motion and the roll was called: Tom Mercer – Aye; Neil Rhoades – Aye; Don Pence – Aye.

At 11:03 a.m., Tom Mercer made a motion to close the Executive Session and was seconded by Don Pence. There was no discussion and the motion carried without opposition. No further action was taken.
