Fiscal Officer's Report: Bill Whidden

- Provided current Fund and Revenue Status Reports as well as the payment register;
- Received notification from the Auditor of State that when SB 310 is approved sample language for a resolution on Coronavirus Aid would be provided.
- Work on the preliminary tax budget continues and is expected to be presented at the next Board meeting.
- Reported that The Bureau of Workers Compensation sent 5 dozen cloth facemasks for use by township employees.

Sheila Knapke of 2175 Seneca Dr., Troy, Ohio asked what next steps should be taken and Mr. Mercer and Mr. Englert both recommended speaking with the County Department of Development.

New Business:

- A. Covid-19 plan of action: Mr. Mercer presented a five-step plan for all township employees to follow.
 - 1. Immediately upon arriving at work take your temperature. Employees are not to work if temperature is over 100 degrees.
 - 2. Social distancing (6ft.) should be maintained whenever possible, except in an emergency. Face covering should be worn whenever 6 ft. of social distancing is not possible.
 - 3. No more than one employee per township vehicle, except in an emergency.
 - 4. All high touch areas of workspaces, equipment, and township building door handles are to be sanitized daily.
 - 5. Employees are to wash their hands, or use hand sanitizer as frequently as possible.
- B. Tom Mercer received a complaint regarding an abandoned swimming pool on Spruce St., as a possible breeding ground for mosquitos. He filed a written request with the health department to investigate.
